
Our office represents LiveNation Entertainment with respect to the regulatory matter referenced above. On behalf of our client, we wish to submit for the Board's consideration the following language, which we propose be added to NAC 368A:

*Except as otherwise provided this section, "service charge" shall mean a charge, in addition to an admission charge, paid by a patron for the performance of an act of doing something useful in exchange for admission to a facility where live entertainment is provided.*

- a) *Fees charged to compensate a ticket seller for providing alternative methods to physically obtain a ticket shall not be deemed a "service charge" if the ticket may be obtained without incurring the fee;*
- b) *Fees charged to reimburse a ticket seller for sending, transmitting, or otherwise distributing sold tickets to consumers shall not be deemed a "service charge" pursuant to this section;*
- c) *If an admission fee is charged, fees charged for event accommodations other than admission including but not limited to transportation, parking, and upgraded levels of access or treatment, shall not be deemed "service charges" pursuant to this section;*
- d) *If a patron may not be admitted without incurring a fee in addition to an admission charge, the fee shall be deemed a "service charge".*
