**Nevada Gaming Revenues and Collections**

**Win Revenue Summary – May 2016**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$958,055,897 for the month of May 2016. This amounts to a 4.53% decrease compared to May 2015, when licensees reported a gaming win of \$1,003,479,007. For the fiscal year (July 1, 2015 through May 31, 2016), gaming win has increased 0.16%.

**Percentage Fee Collections for the Month of June 2016**

The State collected \$51,517,373 in percentage fees during the month of June 2016\*, based upon the taxable revenues generated in May 2016. This represents a 17.13% (or \$10,648,829) decrease compared to the prior year's June, when percentage fee collections were \$62,166,202.
