Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2016

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$887,413,848 for the month of June 2016. This amounts to a 6.80% increase compared to June 2015, when licensees reported a gaming win of \$830,908,905. For the fiscal year (July 1, 2015 through June 30, 2016), gaming win has increased 0.66%.

Percentage Fee Collections for the Month of July 2016

The State collected \$48,443,489 in percentage fees during the month of July 2016*, based upon the taxable revenues generated in June 2016. This represents a 3.3% (or \$1,669,564) decrease compared to the prior year's July, when percentage fee collections were \$50,113,053.
