**GCB RECOMMENDS:**

**APPROVAL, FOURTEENTH REVISED ORDER OF REGISTRATION, DRAFT #1; CONDITIONED:**

- (1) THE LICENSEE MUST COMPLY WITH THE NGC REGULATION 6.090 AS IT RELATES TO THE SUBMISSION OF AN ADEQUATE INTERNAL CONTROL SYSTEM AND COMPLIANCE WITH MINIMUM INTERNAL CONTROLS STANDARDS FOR A COMPUTERIZED SPORTS POOL.**
- (2) THE SURVEILLANCE SYSTEM MUST BE REVIEWED AND APPROVED BY THE NGCB ENFORCEMENT DIVISION WITHIN 30 DAYS OF THE ISSUANCE OF THE NEVADA GAMING LICENSE, AND THEREAFTER BE MAINTAINED AT OR ABOVE THE STANDARD THAT HAS BEEN APPROVED.**
- (3) ANY CHANGE IN ANY AGREEMENT, OR THE CREATION OF ANY NEW AGREEMENT, BETWEEN COAST HOTELS AND CASINOS, INC. AND THE CANNERY HOTEL CASINO AND COAST HOTELS AND CASINOS, INC. AND EASTSIDE CANNERY CASINO & HOTEL MUST BE REPORTED TO THE NGCB WITHIN 30 DAYS OF SUCH CHANGE.**
- (4) EXCEPT AS OTHERWISE PROVIDED FOR BY THE NCGB CHAIRMAN OR HIS DESIGNEE, THE TICKET WRITERS AND SPORTS POOL MANAGER OF THE CANNERY HOTEL AND CASINO, LLC, DBA THE CANNERY HOTEL CASINO, AND NEVADA PALACE, LLC, DBA EASTSIDE CANNERY CASINO & HOTEL ARE DEEMED EMPLOYEES OF COAST HOTELS AND CASINOS, INC., PURSUANT TO THE SPORTS POOL SERVICES AGREEMENT BETWEEN COAST HOTELS AND CASINOS, INC., DBA THE CANNERY HOTEL CASINO – SPORTS POOL, AT THE CANNERY HOTEL CASINO, AND COAST HOTELS AND CASINOS, INC., DBA EASTSIDE CANNERY CASINO & HOTEL – SPORTS POOL AT EASTSIDE CANNERY CASINO & HOTEL, AND THE CANNERY HOTEL AND CASINO, LLC, DBA THE CANNERY HOTEL CASINO, AND NEVADA PALACE, LLC, DBA EASTSIDE CANNERY CASINO & HOTEL, FOR PURPOSES OF COMPLIANCE WITH NRS CHAPTER 463 AND NGC REGULATIONS PROMULGATED THEREUNDER.**
