**2016-03RP: POSSIBLE AMENDMENTS TO NEVADA GAMING COMMISSION REGULATIONS 22.061, 22.062, AND 22.063 REGARDING RECORDKEEPING, REPORTING, AND PAYOUT REQUIREMENTS FOR BOOKS AND SATELLITE BOOKS.**

For Possible Action

**PURPOSE:** To require books and/or satellite books to record and maintain certain information with regard to payouts in excess of \$10,000.00 on winning wagers; to require books and/or satellite books to report certain information to the Nevada Gaming Control Board with regard to payouts in excess of \$10,000.00 on winning wagers; to prohibit multiple payouts on wagers in order to avoid recording, maintaining, or reporting certain information with regard to payouts in excess of \$10,000.00 on winning wagers; to prohibit wagers structured to avoid recording, maintaining, or reporting certain information with regard to payouts in excess of \$10,000.00 on winning wagers; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed regulation changes will be considered by the Commission in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the Nevada Gaming Commission at the May 18, 2017 meeting, and may be continued and heard at subsequent meetings of the Nevada Gaming Commission as required to effectuate the above-stated purposes.
