Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2017

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$895,427,384 for the month of June 2017. This amounts to a 0.90% increase compared to June 2016, when licensees reported a gaming win of \$887,464,756. For the fiscal year (July 1, 2016 through June 30, 2017), gaming win has increased 2.90%.

Percentage Fee Collections for the Month of July 2017

The State collected \$51,806,258 in percentage fees during the month of July 2017*, based upon the taxable revenues generated in June 2017. This represents a 5.77% (or \$2,827,456) increase compared to the prior year's July, when percentage fee collections were \$48,978,802.
