Instructions

- A. This report must be filed and fees paid PRIOR to placing slot machines into operation (NRS 463.373). If slot machines are to be added after the beginning of a calendar quarter, you must file a supplemental NGC-14. State law requires that a penalty will be charged for late payments.
- B. The total number of slot machines to be operated must be included on this report, regardless of ownership.
- C. Report all slot machines, pinball machines, video machines, and similar devices by denomination.
- D. Report slot machines and devices with denominations greater than \$1.00 under "Other".
- E. If slot machines are added during a quarter, the amount due is the difference between the amount previously paid and the total amount due based on the total number of slot machines after such addition.
- F. The annual slot machine tax will apply to additions, and a NGC-04 form must be filed and taxes paid.
