Approval to Offer Wagers on the 2012 World Series of Poker

On May 3, 2012, the Gaming Control Board granted approval to offer wagers on the 2012 World Series of Poker pursuant to the provisions of Regulation 22.120. Approval is granted for all licensed books to post and accept wagers on the winner of the events listed below, subject to the following conditions:

- Licensed books electing to offer these wagers must provide the Enforcement Division with notification of terms via email at ops@gcb.nv.gov
- Wagering is to be only upon those players who will be participating in the final day of each event.
- Acceptance of wagers must cease five minutes prior to the first hand being dealt on each event and may not be reinstated at any time during the course of play.
- The official source of results shall be Poker News (www.pokernews.com).
- All audit procedures detailed in Industry Letter 2011-48 must be adhered to.
- Deviations from, or additions to the propositions listed below, will require a written request for an addendum to this approval.
