Win Revenue Summary - March 1999

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$747,048,399 for the month of March 1999. This amounts to a 10.94% increase compared to March 1998, when licensees reported a gaming win of \$673,362,773.

Percentage Fee Tax Collections for the Month of April 1999

The State collected \$55,914,769 in percentage fee taxes during the month of April 1999, based upon the taxable revenues generated in March 1999. This represents a 0.82% (or \$464,054) decrease compared to the prior year's April (1998), when percentage fee collections were \$56,378,823.

On a ten-month fiscal-year-to-date (July 1, 1998 through April 30, 1999), the State of Nevada collected \$411,261,025 in percentage fee taxes. This represents an 8.37% increase from the prior fiscal year ten-month period when collections totaled \$379,498,659.
