Win Revenue Summary - July 1999

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$733,649,296 for the month of July 1999. This amounts to a 4.77% increase compared to July 1998, when licensees reported a gaming win of \$700,219,702.

Percentage Fee Tax Collections for the Month of August 1999

The State collected \$46,028,625 in percentage fee taxes during the month of August 1999, based upon the taxable revenues generated in July 1999. This represents a 8.61% (or \$3,649,971) increase compared to the prior year’s August (1998), when percentage fee collections were \$42,378,654.

On a two-month fiscal-year-to-date (July 1, 1999 through August 31, 1999), the State of Nevada collected \$85,374,205 in percentage fee taxes. This represents a 10.16% increase from the prior fiscal year two-month period when collections totaled \$77,501,544.
