Win Revenue Summary - August 1999

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$762,821,573 for the month of August 1999. This amounts to a 11.28% increase compared to August 1998, when licensees reported a gaming win of \$685,509,744.

Percentage Fee Tax Collections for the Month of September 1999

The State collected \$42,217,645 in percentage fee taxes during the month of September 1999, based upon the taxable revenues generated in August 1999. This represents a 13.23% (or \$4,931,731) increase compared to the prior year's September (1998), when percentage fee collections were \$37,285,914.

On a three-month fiscal-year-to-date (July 1, 1999 through September 30, 1999), the State of Nevada collected \$127,595,444 in percentage fee taxes. This represents a 11.16% increase from the prior fiscal year three-month period when collections totaled \$114,787,458.
