Win Revenue Summary - September

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$819,557,629 for the month of September 1999. This amounts to a **23.17% increase** compared to September 1998, when licensees reported a gaming win of \$655,403,577.

Percentage Fee Tax Collections for the Month of October 1999

The State collected \$49,447,256 in percentage fee taxes during the month of October 1999, based upon the taxable revenues generated in September 1999. This represents a 27.5% (or \$10,664,398) increase compared to the prior year's October (1998), when percentage fee collections were \$38,782,858.

On a four-month fiscal-year-to-date (July 1, 1999 through October 31, 1999), the State of Nevada collected \$177,042,700 in percentage fee taxes. This represents a 15.28% increase from the prior fiscal year four-month period when collections totaled \$153,570,316.
