**Win Revenue Summary – December 2000**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$794,088,231 for the month of December 2000. This amounts to a 5.79% increase compared to December 1999, when licensees reported a gaming win of \$750,619,645.

**Percentage Fee Tax Collections for the Month of January 2001**

The State collected \$30,104,556 in percentage fee taxes during the month of January 2001, based upon the taxable revenues generated in December 2000. This represents a 13.03% (or \$4,511,044) decrease compared to the prior year's January (2000), when percentage fee collections were \$34,615,600.

On a seven-month fiscal-year-to-date (July 1, 2000 through January 31, 2001), the State of Nevada collected \$306,187,017 in percentage fee taxes. This represents a 1.05% decrease from the prior fiscal year seven-month period when collections totaled \$309,425,228.
