Win Revenue Summary – March 2002

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$807,126,571 for the month of March 2002. This amounts to a **5.78% decrease** compared to March 2001, when licensees reported a gaming win of \$856,600,290.

Percentage Fee Tax Collections for the Month of April 2002

The State collected \$60,561,056 in percentage fee taxes during the month of April 2002, based upon the taxable revenues generated in March 2002. This represents an 11.65% (or \$7,984,991) decrease compared to the prior year’s April (2001), when percentage fee collections were \$68,546,047.

On a ten-month fiscal-year-to-date (July 1, 2001 through April 30, 2002), the State of Nevada collected \$448,590,591 in percentage fee taxes. This represents a 4.60% decrease from the prior fiscal year ten-month period when collections totaled \$470,220,831.
