Win Revenue Summary – May 2003

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$805,698,010 for the month of May 2003. This amounts to a 3.96% decrease compared to May 2002, when licensees reported a gaming win of \$838,925,045. Comparing back to May 2001, prior to the tragic events of September 11th and the accelerated downturn in our tourist-based economy, gaming win declined 4.55%.

Percentage Fee Tax Collections for the Month of June 2003

The State collected \$49,265,130 in percentage fee taxes during the month of June 2003, based upon the taxable revenues generated in May 2003. This represents a 14.87% (or \$8,602,527) decrease compared to the prior year's June (2002), when percentage fee collections were \$57,867,657.

On a twelve-month fiscal-year-to-date (July 1, 2002 through June 30, 2003), the State of Nevada collected \$559,105,299 in percentage fee taxes. This represents a 0.81% increase from the prior fiscal year twelve-month period when collections totaled \$554,639,216.
