Nevada Gaming Revenues and Collections

Win Revenue Summary – July 2003

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$825,476,568 for the month of July 2003. This amounts to a 2.63% increase compared to July 2002, when licensees reported a gaming win of \$804,345,022.

Percentage Fee Tax Collections for the Month of August 2003

The State collected \$53,921,256 in percentage fee taxes during the month of August 2003, based upon the taxable revenues generated in July 2003. This represents a 12.58% (or \$6,023,814) increase compared to the prior year's August (2002), when percentage fee collections were \$47,897,442.

Fiscal Year 2004 Forecast

Compared to the May 2003 Economic Forum's projections, percentage fee collections through the first two months of fiscal year 2004 are 7.7% or (\$7,070,246) above their forecast. For the remaining ten months, percentage fee collections will need to increase by 14.2% percent per month in order to meet the Economic Forum's projections with adjustments for the increased percentage fee rates, which go into effect with next month's tax returns.
