Nevada Gaming Revenues and Collections

Win Revenue Summary – March 2011

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$958,728,161 for the month of March 2011. This amounts to a 5.13% increase compared to March 2010, when licensees reported a gaming win of \$911,980,728. For the fiscal year (July 1, 2010 through March 31, 2011), gaming win has increased 0.67%.

Percentage Fee Collections for the Month of April 2011

The State collected \$79,631,619 in percentage fees during the month of April 2011, based upon the taxable revenues generated in March 2011. This represents a 0.35% (or \$276,199) decrease compared to the prior year's April, when percentage fee collections were \$79,907,818.
