Nevada Gaming Revenues and Collections

Win Revenue Summary – April 2011

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$806,049,852 for the month of April 2011. This amounts to a 0.58% decrease compared to April 2010, when licensees reported a gaming win of \$810,740,516. For the fiscal year (July 1, 2010 through April 30, 2011), gaming win has increased 0.56%.

Percentage Fee Collections for the Month of May 2011

The State collected \$42,611,469 in percentage fees during the month of May 2011, based upon the taxable revenues generated in April 2011. This represents a 7.25% (or \$2,878,851) increase compared to the prior year's May, when percentage fee collections were \$39,732,618.
