Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$885,745,934 for the month of June 2011. This amounts to a 15.98% increase compared to June 2010, when licensees reported a gaming win of \$763,687,684. For the fiscal year (July 1, 2010 through June 30, 2011), gaming win has increased 2.98%.

Percentage Fee Collections for the Month of July 2011

The State collected \$52,780,570 in percentage fees during the month of July 2011, based upon the taxable revenues generated in June 2011. This represents a 22.84% (or \$9,812,903) increase compared to the prior year's July, when percentage fee collections were \$42,967,667.
