**Nevada Gaming Revenues and Collections**

**Win Revenue Summary – December 2011**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$855,664,287 for the month of December 2011. This amounts to a 2.05% increase compared to December 2010, when licensees reported a gaming win of \$838,499,433. For the fiscal year (July 1, 2011 through December 31, 2011), gaming win has increased 1.24%.

**Percentage Fee Collections for the Month of January 2012**

The State collected \$31,781,012 in percentage fees during the month of January 2012, based upon the taxable revenues generated in December 2011. This represents a 5.96% (or \$1,787,970) increase compared to the prior year's January, when percentage fee collections were \$29,993,042.
