**GCB RECOMMENDS:**

APPROVAL, WITH THE TEMPORARY WAIVERS TO EXPIRE AT 11:59 PM ON MARCH 10, 2011 WITH THE ABILITY FOR AN EXTENSION TO MIDNIGHT OF MARCH 31, 2011 UPON ADMINISTRATIVE APPROVAL OF THE CHAIRMAN OF THE GCB, OR HIS DESIGNEE; AND APPROVAL OF THE NONRESTRICTED GAMING, MANUFACTURER AND DISTRIBUTOR LICENSES LIMITED TO EXPIRE AT MIDNIGHT OF THE 02/13 NGC MEETING ON THE DAY THE ITEM IS HEARD, CONDITIONED:

- (1) THE SURVEILLANCE SYSTEM MUST BE MAINTAINED AT OR ABOVE THE STANDARD THAT HAS BEEN APPROVED.
- (2) WITHIN 60 DAYS OF ISSUANCE OF THE STATE GAMING LICENSE, THE LICENSEE MUST COMPLY WITH NGC REGULATION 6.090 AS IT RELATES TO THE SUBMISSION OF AN ADEQUATE INTERNAL CONTROL SYSTEM AND COMPLIANCE WITH THE MINIMUM INTERNAL CONTROL STANDARDS.
