To adjust the annual gross gaming revenue thresholds applicable to the definitions of Group I and II licensees. Changes to the Group I/Group II threshold correspond to the percentage increase in the "Consumer Price Index" published by the United States Department of Labor, which was 4.1% for calendar 2008; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

2. **CONSIDERATION OF:** Proposed amendments to **NGC REGULATION 6.080, "AUDITED FINANCIAL STATEMENTS."** To adjust the annual gross gaming revenue thresholds applicable to audited and reviewed financial statements submitted by nonrestricted licensees, as required by NRS 463.159.
