**Nevada Gaming Revenues and Collections**

**Win Revenue Summary – October 2012**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$978,808,168 for the month of October 2012. This amounts to a 1.88% increase compared to October 2011, when licensees reported a gaming win of \$960,719,191. For the fiscal year (July 1, 2012 through October 31, 2012), gaming win has increased 4.62%.

**Percentage Fee Collections for the Month of November 2012**

The State collected \$54,486,538 in percentage fees during the month of November 2012, based upon the taxable revenues generated in October 2012. This represents a 16.63% (or \$10,867,770) decrease compared to the prior year's November, when percentage fee collections were \$65,354,308.
