Nevada Gaming Revenues and Collections

Win Revenue Summary – January 2013

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$909,182,243 for the month of January 2013. This amounts to a 12.44% decrease compared to January 2012, when licensees reported a gaming win of \$1,038,359,335. For the fiscal year (July 1, 2012 through January 31, 2013), gaming win has increased 0.41%.

Percentage Fee Collections for the Month of February 2013

The State collected \$67,917,600 in percentage fees during the month of February 2013, based upon the taxable revenues generated in January 2013. This represents an 18.34% (or \$10,524,919) increase compared to the prior year's February, when percentage fee collections were \$57,392,681.
