Nevada Gaming Revenues and Collections

Win Revenue Summary – March 2013

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$914,784,656 for the month of March 2013. This amounts to a 7.04% increase compared to March 2012, when licensees reported a gaming win of \$854,590,337. For the fiscal year (July 1, 2012 through March 31, 2013), gaming win has increased 2.79%.

Percentage Fee Collections for the Month of April 2013

The State collected \$78,338,772 in percentage fees during the month of April 2013, based upon the taxable revenues generated in March 2013. This represents a 9.62% (or \$6,877,715) increase compared to the prior year's April, when percentage fee collections were \$71,461,057.
