The Nevada Gaming Control Board has received from Nevada Disseminator Service, Inc. their notice of intent to submit proposals for the exclusive right to broadcast the following racing meets, conditioned upon the Board waiving the 100-day notice requirement:

Churchill Downs (Fall)	09/11/15 – 11/29/15
Zia Park	09/14/15 – 12/15/15
Delaware County Fair (Harness)	09/16/15 – 09/19/15
Lone Star Park at Grand Prairie (Quarter House)	09/18/15 – 11/14/15

The Board will make an exception under the circumstances, and will waive the 100-day requirement for Nevada Disseminator Service, Inc. and any other licensed disseminator wishing to submit proposals for these meets.
