**Win Revenue Summary – July 2015**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$922,886,804 for the month of July 2015. This amounts to a 0.96% decrease compared to July 2014, when licensees reported a gaming win of \$931,875,046.

**Percentage Fee Collections for the Month of August 2015**

The State collected \$56,947,957 in percentage fees during the month of August 2015\*, based upon the taxable revenues generated in July 2015. This represents a 7.48% (or \$3,961,937) increase compared to the prior year's August, when percentage fee collections were \$52,986,020.
