**PURPOSE:** To update Nevada Administrative Code (NAC) Chapter 368A based on a review of that chapter pursuant to Nevada Revised Statutes (NRS) 233B.050(1)(e) and the adoption of Senate Bill (SB) 266 during the 78<sup>th</sup> (2015) Regular Session of the Nevada Legislature (the update includes adopting new sections, amending certain existing sections, and repealing certain existing sections); and to take such additional action as may be necessary and proper to effectuate the stated purpose.

2. **2016-01R:** Possible Adoption of Amendments to Nevada Gaming Commission (NGC) Regulation 6.030 Relating to the Procedures for Reporting and Paying Gaming Taxes and Fees.

**PURPOSE:** To amend NGC Regulation 6.030 to make it mandatory, rather than optional, that all Nevada gaming licensees report and pay their gaming taxes and fees, and file all reports relating thereto, pursuant to electronic transfer procedures approved by the Nevada Gaming Control Board; and to take such additional action as may be necessary and proper to effectuate this stated purpose.
