**Nevada Gaming Revenues and Collections**

**Win Revenue Summary – October 2016**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$986,203,125 for the month of October 2016. This amounts to an 11.12% increase compared to October 2015, when licensees reported a gaming win of \$887,510,784. For the fiscal year (July 1, 2016 through October 31, 2016), gaming win has increased 4.86%.

**Percentage Fee Collections for the Month of November 2016**

The State collected \$59,554,744 in percentage fees during the month of November 2016\*, based upon the taxable revenues generated in October 2016. This represents a 13.75% (or \$7,199,023) increase compared to the prior year's November, when percentage fee collections were \$52,355,721.
