2017-02R: POSSIBLE AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 26B REGARDING, WITHOUT LIMITATION, OFF-TRACK PARI-MUTUEL OTHER EVENT WAGERING.

PURPOSE: To provide that Regulation 26B governing pari-mutuel wagering on sporting events applies to pari-mutuel wagering on other events; to add “other event” where necessary to Regulation 26B to effectuate the addition of “other event” to Nevada Revised Statute Chapter 464 by SB 240; and to take such additional action as may be necessary and proper to effectuate these stated purposes.
