Nevada Gaming Revenues and Collections

Win Revenue Summary – January 2019

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$984,526,623 for the month of January 2019. This amounts to a 3.01% decrease compared to January 2018, when licensees reported a gaming win of \$1,015,043,568. For the fiscal year (July 1, 2018 through January 31, 2019), gaming win has increased 1.09%.

Percentage Fee Collections for the Month of February 2019

The State collected \$89,415,560 in percentage fees during the month of February 2019*, based upon the taxable revenues generated in January 2019. This represents a 30.28% (or \$20,782,146) increase compared to the prior year's February, when percentage fee collections were \$68,633,414.
