Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2008

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,001,072,500 for the month of September 2008. This amounts to an 5.44% decrease compared to September 2007, when licensees reported a gaming win of \$1,058,687,112. For the fiscal year (July 1, 2008 through September 30, 2008), gaming win has decreased 8.96%.

Percentage Fee Collections for the Month of October 2008

The State collected \$63,551,693 in percentage fees during the month of October 2008, based upon the taxable revenues generated in September 2008. This represents a 14.52% (or \$10,796,200) decrease compared to the prior year's October, when percentage fee collections were \$74,347,893.
