Win Revenue Summary – July 2019

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of **\$1,023,950,453** for the month of July 2019. This amounts to a **2.91% increase** compared to July 2018, when licensees reported a gaming win of **\$994,997,324**.

Percentage Fee Collections for the Month of August 2019

The State collected \$73,918,158 in percentage fees during the month of August 2019*, based upon the taxable revenues generated in July 2019. This represents a 32.45% (or \$18,111,199) increase compared to the prior year's August, when percentage fee collections were \$55,806,959.
