2019-06R: AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 16 REGARDING, WITHOUT LIMITATION, REQUIREMENTS AND PROCEDURES RELATING TO THE FILING OF AN APPLICATION FOR A FINDING OF SUITABILITY BY A PERSON ENGAGING IN CERTAIN PROSCRIBED ACTIVITIES.

PURPOSE: To amend Nevada Gaming Commission (“NGC” or “Commission”) Regulation 16 to adopt the regulations mandated by Section 10.6 of Senate Bill No. 73 from the 80th (2019) session of the Nevada Legislature; to adopt regulations setting forth procedures by which a person, before engaging in certain proscribed activities, directly or indirectly, to materially influence or affect the affairs of a publicly traded corporation that is registered with the Commission, must file an application for a finding of suitability pursuant to Nevada Revised Statute (NRS) 463.643; to adopt regulations setting forth provisions that determine which corporate activities, in addition to those described in subsection 6 of NRS 463.643, influence or affect the affairs of a corporation in such a way that the Commission would require a person to file an application for a finding of suitability pursuant to NRS 463.643; to adopt regulations that provide provisions that ensure that a person is not unduly prohibited from lawfully exercising any of his or her voting rights derived from being a shareholder of a publicly traded corporation; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the NGC at the November 21, 2019 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
