Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2019

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,059,291,018 for the month of September 2019. This amounts to a 6.83% increase compared to September 2018, when licensees reported a gaming win of \$991,600,256. For the fiscal year (July 1, 2019 through September 30, 2019), gaming win has increased 4.68%.

Percentage Fee Collections for the Month of October 2019

The State collected \$66,351,356 in percentage fees during the month of October 2019*, based upon the taxable revenues generated in September 2019. This represents a 21.48% (or \$11,732,342) increase compared to the prior year's October, when percentage fee collections were \$54,619,014.
