Nevada Gaming Revenues and Collections

Win Revenue Summary – January 2020

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,038,196,869 for the month of January 2020. This amounts to a 5.48% increase compared to January 2019, when licensees reported a gaming win of \$984,227,816. For the fiscal year (July 1, 2019 through January 31, 2020), gaming win has increased 2.57%.

Percentage Fee Collections for the Month of February 2020

The State collected \$73,049,145 in percentage fees during the month of February 2020*, based upon the taxable revenues generated in January 2020. This represents an 18.31% (or \$16,378,484) decrease compared to the prior year's February, when percentage fee collections were \$89,427,629.
