Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2020

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$566,806,791 for the month of June 2020. This amounts to a 45.55% decrease compared to June 2019, when licensees reported a gaming win of \$1,040,978,076. For the fiscal year (July 1, 2019 through June 30, 2020), gaming win has decreased 21.67%.

Percentage Fee Collections for the Month of July 2020

The State collected \$344,027 in percentage fees during the month of July 2020*, based upon the taxable revenues generated in June 2020. This represents a 99.39% (or \$56,174,986) decrease compared to the prior year's July, when percentage fee collections were \$56,519,013.
