The State of Nevada, on relation of its NEVADA GAMING CONTROL BOARD (BOARD), Complainant herein filed and served a Complaint, NGC Case No. 20-05, against the above-captioned RESPONDENT alleging certain violations of the Nevada Gaming Control Act and Regulations of the Nevada Gaming Commission.

IT IS HEREBY STIPULATED AND AGREED to by the BOARD and RESPONDENT that the Complaint, NGC Case No. 20-05, filed against RESPONDENT in the above-entitled case, shall be settled on the following terms and conditions:

1. RESPONDENT admits each and every allegation set forth in the Complaint, NGC Case No. 20-05.

2. RESPONDENT fully understands and voluntarily waives the right to a public hearing on the charges and allegations set forth in the Complaint, the right to present and cross-examine witnesses, the right to a written decision on the merits of the Complaint, which must contain findings of fact and a determination of the issues presented, and the right to obtain judicial review of the Nevada Gaming Commission's decision.

1 3. RESPONDENT agrees to pay FIFTEEN THOUSAND DOLLARS and NO
2 CENTS (\$15,000.00) electronically transferred to the *State of Nevada-Nevada Gaming*
3 *Commission* on or before the date this stipulated settlement agreement is accepted by the
4 Nevada Gaming Commission. Said payment shall be made by a method of electronic
5 payment approved by the Tax and License Division of the BOARD pursuant to NRS
6 353.1467. Interest on the fine shall accrue pursuant to NRS 17.130 on any unpaid
7 balance computed from the date payment is due until payment is made in full.

8 4. In consideration for the execution of this Stipulation for Settlement,
9 RESPONDENT, for itself, its heirs, executors, administrators, successors, and assigns,
10 hereby releases and forever discharges the State of Nevada, the Nevada Gaming
11 Commission, the Nevada Gaming Control Board, the Nevada Attorney General and each
12 of their members, agents, and employees in their individual and representative
13 capacities, from any and all manner of actions, causes of action, suits, debts, judgments,
14 executions, claims, and demands whatsoever known or unknown, in law and equity, that
15 RESPONDENT ever had, now have, may have, or claim to have against any and all of the
16 persons or entities named in this paragraph arising out of, or by reason of, the
17 investigation of the allegations in the Complaint and this disciplinary action, NGC Case
18 No. 20-05, or any other matter relating thereto.

19 5. In consideration for the execution of this Stipulation for Settlement,
20 RESPONDENT hereby indemnifies and holds harmless the State of Nevada, the Nevada
21 Gaming Commission, the Nevada Gaming Control Board, the Nevada Attorney General,
22 and each of their members, agents, and employees in their individual and representative
23 capacities against any and all claims, suits and actions, brought against the persons
24 named in this paragraph by reason of the investigation of the allegations in the
25 Complaint, filed in this disciplinary action, NGC Case No. 20-05, and all other matters
26 relating thereto, and against any and all expenses, damages, charges and costs, including
27 court costs and attorney fees, which may be sustained by the persons and entities named
28 in this paragraph as a result of said claims, suits and actions.

1 6. RESPONDENT enters into this Stipulation for Settlement freely and
2 voluntarily and acknowledges that RESPONDENT had an opportunity to consult with
3 counsel prior to entering into this Stipulation for Settlement. RESPONDENT further
4 acknowledges that this Stipulation for Settlement is not the product of force, threats, or
5 any other form of coercion or duress, but is the product of discussions between
6 RESPONDENT and the attorney for the BOARD.

7 7. RESPONDENT and the BOARD acknowledge that this Stipulation for
8 Settlement is made to avoid litigation and economize resources. The parties agree and
9 understand that this Stipulation for Settlement is intended to operate as full and final
10 settlement of the Complaint filed against RESPONDENT in the above-entitled
11 disciplinary case, NGC Case No. 20-05.

12 8. RESPONDENT and the BOARD recognize and agree that the Nevada Gaming
13 Commission has the sole and absolute discretion to determine whether to accept this
14 Stipulation for Settlement. RESPONDENT and the BOARD hereby waive any right they
15 may have to challenge the impartiality of the Nevada Gaming Commission to hear the
16 above-entitled case on the matters embraced in the Complaint if the Nevada Gaming
17 Commission determines not to accept this Stipulation for Settlement. If the Nevada
18 Gaming Commission does not accept the Stipulation for Settlement, it shall be withdrawn
19 as null and void and RESPONDENT's admissions, if any, that certain violations of the
20 Nevada Gaming Control Act and the Regulations of the Nevada Gaming Commission
21 occurred shall be withdrawn.

22 9. RESPONDENT and the BOARD agree and understand that this Stipulation
23 for Settlement is intended to operate as the full and final settlement of the Complaint
24 filed in NGC Case No. 20-05. The parties further agree and understand that any oral
25 representations are superseded by this Stipulation for Settlement and that only those
26 terms memorialized in writing herein shall be effective.

27 10. RESPONDENT agrees and understands that although this Stipulation for
28 Settlement, if approved by the Nevada Gaming Commission, will settle the Complaint

1 filed in NGC Case No. 20-05, that the allegations contained in the Complaint filed in
2 NGC Case No. 20-05, and the terms of this Stipulation for Settlement, may be considered
3 by the BOARD and/or the Nevada Gaming Commission, with regards to any and all
4 applications by RESPONDENT that are currently pending before the BOARD or the
5 Nevada Gaming Commission, or that are filed in the future with the BOARD.

6 11. RESPONDENT and the BOARD shall each bear their own costs incurred in
7 this disciplinary action, NGC Case No. 20-05.

8 12. RESPONDENT, by executing this Stipulation for Settlement, affirmatively
9 waives all notices required by law for this matter including, but not limited to, notices
10 concerning consideration of the character or misconduct of a person (Nevada Revised
11 Statute ((NRS) 241.033), notices concerning consideration of administrative action
12 against a person (NRS 241.034), and notices concerning hearings before the Nevada
13 Gaming Commission (NRS 463.312). Regardless of the waiver of legal notice
14 requirements, the BOARD and Nevada Gaming Commission will attempt to provide
15 reasonable notice of the time and place of the hearing. Further, in negotiating this
16 Stipulation for Settlement, RESPONDENT acknowledges that the BOARD has provided
17 RESPONDENT with the date and time of the Nevada Gaming Commission hearing
18 during which the BOARD anticipates the Nevada Gaming Commission will consider
19 approving this Stipulation for Settlement.




