Nevada Gaming Revenues and Collections

Win Revenue Summary – August 2020

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$743,038,562 for the month of August 2020. This amounts to a 22.08% decrease compared to August 2019, when licensees reported a gaming win of \$953,623,896. For the fiscal year (July 1, 2020 through August 31, 2020), gaming win has decreased 24.20%.

Percentage Fee Collections for the Month of September 2020

The State collected \$78,294,941 in percentage fees during the month of September 2020*, based upon the taxable revenues generated in August 2020. This represents a 56.38% (or \$28,228,027) increase compared to the prior year's September, when percentage fee collections were \$50,066,914.
