2020-09R: CONSIDERATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 12.060 REGARDING, WITHOUT LIMITATION, REDEMPTION OF CHIPS AND TOKENS.

PURPOSE: In accordance with NRS 463.145, and NRS 463.150, to clarify that a licensee shall not redeem its chips or tokens if presented by a person who the licensee knows or reasonably should know did not obtain the chips or tokens directly and lawfully from the licensee's gaming establishment; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

Regulation adopted, draft dated October 15, 2020, effective upon adoption.

2021-01R: CONSIDERATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 7A REGARDING, WITHOUT LIMITATION, REVIEWING AND UPDATING REGULATION 7A.

My name is Jon Humbert and I live in Reno. I'm commenting today to support the agenda item to revisit and revise sports betting account sign-ups.

As we know, iGaming and online sports betting took 2020 by storm. Hedge funds, state legislatures, and marketing partners have pushed mobile sportsbooks to new highs.

Yet Nevada continues to lag behind in so many ways. A near-monopoly by brick-and-mortar companies has created a hodgepodge of unintuitive apps, middling betting menus, and archaic sign-up procedures.

It boggles my mind as I speak with friends across the country. They've had it incredibly easy to sign up with Draftkings, FanDuel, and even MGM. Yet Nevada, the undisputed cleanest and well-run gaming state---blocks these options, bank account deposits, and more.

We're leaving money on the table and putting an absurd burden on recreational bettors. If tourists want to enjoy the thrill of the sportsbook on gameday, that's awesome and can't be found anywhere in the country.

But Nevada needs to be a leader for *locals,* encourage competition, welcome online-only sportsbooks, and bring in more revenue to our top-flight gaming community.
