2021-06R: NOTICE OF HEARING FOR CONSIDERATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 7A.017 REGARDING, WITHOUT LIMITATION, TO REVISE AND UPDATE THE LIMITATIONS PERIOD FOR PATRON DISPUTES AND TO TAKE SUCH ADDITIONAL ACTION AS MAY BE NECESSARY AND PROPER TO EFFECTUATE THIS STATED PURPOSE.

PURPOSE: To revise and update the limitations period for patron disputes and to take such additional action as may be necessary and proper to effectuate this stated purpose.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

These items will be heard by the NGC at the September 23, 2021 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
