Nevada Gaming Revenues and Collections

Win Revenue Summary – August 2021

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,165,801,985 for the month of August 2021. This amounts to a 56.91% increase compared to August 2020, when licensees reported a gaming win of \$742,974,890. For the fiscal year (July 1, 2021 through August 31, 2021), gaming win has increased 68.39%.

Percentage Fee Collections for the Month of September 2021

The State collected \$74,141,098 in percentage fees during the month of September 2021*, based upon the taxable revenues generated in August 2021. This represents a 5.34% (or \$4,181,253) decrease compared to the prior year's September, when percentage fee collections were \$78,322,351.
