Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2022

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,277,068,155 for the month of June 2022. This amounts to an 8.06% increase compared to June 2021, when licensees reported a gaming win of \$1,181,821,147. For the fiscal year (July 1, 2021 through June 30, 2022), gaming win has increased 37.34%.

Percentage Fee Collections for the Month of July 2022

The State collected \$71,230,474 in percentage fees during the month of July 2022*, based upon the taxable revenues generated in June 2022. This represents a 22.63% (or \$20,837,017) decrease compared to the prior year's July, when percentage fee collections were \$92,067,491.
