Win Revenue Summary – July 2022

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,315,987,732 for the month of July 2022. This amounts to a 3.17% decrease compared to July 2021, when licensees reported a gaming win of \$1,359,057,512.

Percentage Fee Collections for the Month of August 2022

The State collected \$90,389,289 in percentage fees during the month of August 2022*, based upon the taxable revenues generated in July 2022. This represents a 7.48% (or \$7,312,814) decrease compared to the prior year's August, when percentage fee collections were \$97,702,103.
