**2022-06R: CONSIDERATION AND POSSIBLE ADOPTION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 5.**

**PURPOSE:** To amend the Nevada Gaming Commission (“NGC”) Regulations to create cybersecurity requirements for certain gaming operators; To set forth the importance of gaming operators to take necessary steps to protect their information systems from a cyber attack; To define certain terms used in the new regulation; To provide what entities must comply with the new regulation; To require covered entities to perform an annual risk assessment and to determine what best practices are necessary to mitigate the risk of a cyber attack; To impose certain requirements should a covered entity experience certain cyber attacks; Require covered entities that are Group 1 licensees to implement certain procedures to review and verify compliance with regulation; To require gaming operators to document all procedures taken to comply with the new regulation, maintain the records for five years, and provide them to the Nevada Gaming Control Board (“Board”) upon request; Require gaming operators to attest to the performance of the annual risk assessment required under the new regulation; To provide that a failure to comply with the requirements of the new regulation constitutes an unsuitable method of operation ; And to take such additional actions as may be necessary and proper to effectuate this stated purpose.

Hello. My name is Kathleen Penna. I'm a cocktail server at the Red Rock casino. I started working with Station Casinos in 1997, opening Sunset Station as a cocktail server. In the nine years I worked at Sunset Station, we had three rebids, which allowed us to change what shifts we were working.

I transferred to open the Red Rock casino in 2006. I started in the bingo room as a cocktail server and am currently still in the bingo room. After several years, Red Rock had a rebid in the beverage department for all the bartenders and slot cocktail servers only. Every other cocktail server, including bingo, race and sports book, poker, and the pit was excluded from this rebid.

When I found out about this I went to the beverage managers, beverage director, Human Resources, corporate, and finally to the General Manager of Red Rock. With the majority of the cocktail servers in agreement, and after a full year of trying to follow the proper chain of command to request a full rebid without classifications or pods, we were informed by Scott Nelson, the General Manager of Red Rock, that there would be no full rebid. He offered no explanation as to why.

For the past 16 years I have been in the same room, same shifts, same hours, with no opportunity to change it to fit my life as it has changed over the years. To make a change I would have to give up my seniority of 25 years and my benefits to take a part-time shift in another classification.

I am not the only cocktail server who has put in many years with the company and feels like there is no hope for advancement or change. We feel like the company isn't listening to us.

October marks one year since the Culinary Union proposed in negotiations to change this system. As of today the company offered NOTHING in return.

We voted for the Culinary Union at Red Rock, and we want the company to respect that. I would like to know when someone will hold them accountable?

Thank you.

My name is Ken Liu. I'm with the Culinary Union. We continue to ask you to investigate Station Casinos in order to maintain the integrity of the state's regulatory system. The issues raised by this company go beyond NLRB cases and repeat violations of federal labor law.

Today I want to bring your attention to potential violations of federal election law by Frank Fertitta III and Lorenzo Fertitta, who are controlling owners of Station Casinos and holders of suitability findings by this body.

The two of them made \$756,300 in political contributions at the federal level between 2019 and 2021. The Federal Election Commission reports by the recipients of these donations contain false, outdated information.

For example, in December 2019, Lorenzo Fertitta made a contribution of \$147,000 to the McConnell Victory Committee. The receipt lists his employer as UFC and occupation as CEO. The Fertittas sold the UFC in 2016 and sold their remaining minority stake in 2017, so the information on Mr. Fertitta's donation receipt is years out of date and as a result false. There are 24 other similar reports of false, outdated information about employer and occupation on the receipts of Fertittas' donations between 2019 and 2021.

The Culinary Union submitted a letter to the FEC in April to ask for a determination as to whether this inaccurate information was knowingly submitted in violation of Title 52 of the US Code on voting and elections. The FEC has numbered this as a matter under review. As of today, we have not been notified of any final action.

While federal regulators review this matter, we urge you to directly ask Station Casinos about such false, outdated information related to political contributions by its controlling owners. We think it is important to find out whether Frank Fertitta and Lorenzo Fertitta might have been responsible for inaccurate information being reported to the FEC.

Specifically, we ask you to consider whether Frank and Lorenzo Fertitta might have failed to "comply with or make provision for compliance with all federal, state, or local laws and regulations" – in this case, federal election laws and regulations – under Regulation 5.011.1(f).<sup>1</sup>

We continue to look forward to your taking action. Thank you.

**RE: Fertitta false information on 25 FEC receipts**

Dear Associate General Counsel Kitcher and OGC Staff,

We write to bring to your attention 25 FEC Form 3X itemized receipts submitted with false information about employer and occupation totaling \$756,300 in contributions from Lorenzo Fertitta and Frank Fertitta III to 11 FEC registered entities between 2019 and 2021. We ask you determine whether this false information was knowingly submitted in violation of Title 52 of the US Code on voting and elections.

FEC Form 3X Report of Receipts and Disbursements says "Submission of false, erroneous, or incomplete information may subject the person signing this Report to the penalties of 52 U.S.C. § 30109." The Federal Election Campaign Act US Code says the treasurer of a political committee shall keep an account of "the identification of any person who makes a contribution or contributions aggregating more than \$200 during a calendar year, together with the date and amount of any such contribution" [52 U.S.C. § 30102(c)(3)] and defines identification as "in the case of any individual, the name, the mailing address, and the occupation of such individual, as well as the name of his or her employer" [52 U.S.C. § 30101(13)].

Lorenzo Fertitta's FEC receipts from 2019 and 2021 lists his employer as the Ultimate Fighting Championship (UFC) with occupation as Chairman of the Board or CEO, and receipts from 2019 lists Lorenzo's employer as Zuffa LLC, the UFC parent company, with occupation as CEO or Owner. One Lorenzo Fertitta FEC receipt from 2019 shows employer as Fertitta Entertainment LLC with occupation as Chairman and CEO. Frank Fertitta's FEC receipts from 2019 lists his employer as UFC parent company Zuffa LLC with occupation as owner, and receipts from 2019-2021 list Frank's employer as Fertitta Entertainment LLC with occupation as chairman and CEO, and in one instance, owner.

This information in those FEC receipts is outdated and, as a result, false.

Lorenzo Fertitta and Frank Fertitta III were co-owners of the Ultimate Fighting Championship via its parent company, Zuffa LLC, until the UFC was sold to new owners in 2016.<sup>1</sup> According to SEC filings in 2019, 2020 and 2021, Lorenzo and Frank co-owned Zuffa LLC until it was sold in August 2016, and
