**2022-06R: CONSIDERATION AND POSSIBLE ADOPTION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 5.**

**PURPOSE:** To amend the Nevada Gaming Commission (“NGC”) Regulations to create cybersecurity requirements for certain gaming operators; To set forth the importance of gaming operators to take necessary steps to protect their information systems from a cyber attack; To define certain terms used in the new regulation; To define which gaming operators qualify as covered entities; To require covered entities to perform an initial risk assessment and determine what best practices are necessary to mitigate the risk of a cyber attack; To require covered entities to monitor and evaluate cybersecurity risks to its business operation on an ongoing basis and modify best practices and risk assessments as necessary; To impose certain requirements should a covered entity experience certain cyber attacks; To require covered entities that are Group 1 licensees to implement certain procedures to review and verify compliance with regulation; To require covered operators to document all procedures taken to comply with the new regulation, maintain the records for five years, and provide them to the Nevada Gaming Control Board upon request; To provide that a failure to comply with the requirements of the new regulation constitutes an unsuitable method of operation; And to take such additional actions as may be necessary and proper to effectuate this stated purpose.

Good morning. My name is Diamante Asberry. I'm here on behalf of the Culinary Union.

Last month we spoke to you about Station Casinos' MUD lists. These were lists of Station Casinos workers prepared by management indicating which employees were pro-management, pro-union or don't know. So MUD is acronym where M meant "management," U meant "union" and D meant "don't know." When rehiring workers it is against the law to discriminate based on union preference.

The company started using MUD lists in 2019. Then, two months after the COVID shutdown in 2020, the VP and GM of Palace Station wrote his property managers in May 2020 and said, "Our MUD list needs to [be] updated. Regina please apply the final version of our hourly cut list to our current and last edition of the MUD list so that we can review that asap."

Two months later, the Director of Hotel Operations at Palms Place told the Corporate VP of Hotel & Revenue Management, "Looking at the MUD list we have 13 GRA's we would bring back, the remaining we would prefer external. 2 Houseman we would bring back, the remaining we would prefer external." Station workers were in the midst of the pandemic and financial crises, and Station was using MUD lists decide which employees to bring back.

In August 2020, Boulder Station HR Director wrote to the property's Executive Team and said, "As discussed, all candidates that you and your managers wish to rehire need to go through a vetting process before being sent for D&B. A review of your department MUD list is necessary as well."

For what *legitimate* reason did Station Casinos create MUD lists to keep track of which employees were pro-management and which employees were pro-union? And why would it

need to review these MUD lists before rehiring employees if not to discriminate based on union preference? That's illegal.

Station's use of MUD lists caused damage to our community and to our industry. So we are asking you again for a comprehensive investigation into this company.

My name is Dan Serwinowski. I am a banquet server at Red Rock Casino. I had worked there for 14 years before being laid off during the pandemic, then brought back on as a new hire, without my seniority or benefits.

I would like to wish you all happy holidays, and I also want to remind you that my coworkers and I are still fighting for a union contract. We want to be respected at work. We are asking you to hold Station Casinos accountable for the way that workers are treated.
