- APPROVAL** – required if the total value of all charitable lottery prizes is \$25,000 - \$500,000 in a calendar year (\$25 fee - Annual report required).

Applications must be submitted 30 days prior to the commencement of any lottery activity, including advertising or ticket sales. Organizations are encouraged to file applications earlier than the required 30 days.
