I submit to the jurisdiction of the State of Nevada, the Board, and the Commission and agree to be governed and bound by the laws of the State of Nevada and the regulations of the Commission. I agree to comply with any drug testing required by the Board Chair or the Chair's designee.

I understand applying for this registration is seeking the granting of a privilege, and the burden of proving my qualifications to receive such a registration is at all times my responsibility. I accept any risk of adverse public notice, embarrassment, criticism, or other action, or financial loss which may result from action with respect to an application, and expressly waives any claim for damages as a result thereof.

The undersigned, as a condition and consideration of doing business with a licensee or club venue operator agrees and covenants with the State of Nevada, the Nevada Gaming Commission and the Nevada Gaming Control Board to be governed and bound by the Nevada Gaming Control Act, NRS 463.011 et seq., and the Regulations of the Nevada Gaming Commission and Nevada Gaming Control Board as said statutes and regulations may apply to its business and activities relating to gaming within the State of Nevada.
