Win Revenue Summary - September 1998

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$665,509,545 for the month of September 1998. This amounts to a 5.60% increase compared to September 1997, when licensees reported a gaming win of \$630,202,825.

Percentage Fee Tax Collections for the Month of October 1998

The State collected \$38,782,860 in percentage fee taxes during the month of October 1998, based upon the taxable revenues generated in September 1998. This represents a 8.78% (or -\$3,731,218) decrease compared to the prior year's October (1997), when percentage fee collections were \$42,514,078.

On a four-month fiscal-year-to-date (July 1, 1998 through October 31, 1998), the State of Nevada collected \$153,570,385 in percentage fee taxes. This represents a 2.84% increase from the prior fiscal year four-month period when collections totaled \$149,333,118.
