Win Revenue Summary – April 2000

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$785,680,666 for the month of April 2000. This amounts to a **13.97% increase** compared to April 1999, when licensees reported a gaming win of \$689,401,582.

Percentage Fee Tax Collections for the Month of May 2000

The State collected \$37,241,324 in percentage fee taxes during the month of May 2000, based upon the taxable revenues generated in April 2000. This represents a 1.16% (or \$426,860) increase compared to the prior year's May (1999), when percentage fee collections were \$36,814,464.

On an eleven-month fiscal-year-to-date (July 1, 1998 through May 31, 2000), the State of Nevada collected \$508,114,086 in percentage fee taxes. This represents a 13.40% increase from the prior fiscal year eleven-month period when collections totaled \$448,075,489.
